ARTICULATION AGREEMENT BETWEEN JAMESTOWN COMMUNITY COLLEGE AND GENESEE COMMUNITY COLLEGE 2004-05

PURPOSE OF AGREEMENT

This document establishes a transfer articulation agreement between Genesee Community College (GCC) and Jamestown Community College (JCC). Its purpose is to define the method by which students can satisfy the liberal arts requirements at GCC and the aviation requirements at JCC to earn the A.A.S. Professional Piloting degree at JCC.

GENERAL GUARANTEE

Students who complete the GCC general education core requirements as listed on the attached JCC/GCC Course Comparison Sheet, with a grade of "C" or higher in each of the courses, are guaranteed to have that list of GCC courses transfer to, and satisfy, the general education core requirements for the A.A.S. Professional Piloting degree offered by JCC. Since GCC does not offer a course in Meteorology, students will need to fulfill that requirement by taking the course at JCC or some other accredited institution. Students may complete equivalent courses online from other institutions and have them transfer to JCC as well. Since some of the GCC courses listed in the Course Comparison Sheet are not entirely equivalent to the corresponding JCC course, the transferability of these courses applies only within the context of this agreement. The courses will not necessarily transfer to JCC individually or toward any other degree program. If a student completes only part of the list at GCC and transfers to JCC, remaining course requirements will be determined on an individual basis.

CHANGES IN DEGREE REQUIREMENTS

Students who maintain continuous enrollment in the program will, if curricular changes occur, have the choice of following the curriculum in place at the time they were accepted into the program or of following the revised curriculum.

TIME FRAME FOR OFFER OF ADMISSION

The offer by JCC to accept these courses will be honored as long as the degree is offered at JCC.

TIME FRAME FOR ENROLLMENT

Students planning to participate in this program will officially be Jamestown Community College students. That is, one must apply for Admission and Financial Aid to JCC. Because of the significant additional costs associated with the flight training, students are encouraged to not only apply for financial aid but work to ensure that a complete financial plan is in effect long before the actual time that they begin taking classes and flight training. Students will normally be part-time students at both institutions but will be considered full-time at JCC under the standard allowable financial aid consortium agreement between the two colleges.

OPPORTUNITIES FOR FLIGHT TRAINING

As part of the agreement to make the JCC A.A.S. Professional Piloting degree available to students from the GCC service area, JCC will contract with Bill Law Aviation (BLA) in Rochester, New York, to provide the required ground school and flight training. Bill Law Aviation is an FAA approved Part 141 training provider and is very interested in working with JCC. A copy of the agreement with BLA will accompany this contract when finalized.

EFFECTIVE DATE AND PROVISION FOR REVIEW OF AGREEMENT

This agreement will become effective on (date). Either institution may terminate this agreement upon six months written notification to the other institution. Review of this agreement will be made every three years, but failure to conduct such a review shall in no way impair any obligation of this agreement.
