2012-2013 General Studies Transfer Equivalents and Articulation Agreement

To transfer to the Graziadio School of Business and Management's Bachelor of Science in Management program, a student must have earned an acceptable grade point average on 68 or more transferable semester units from a regionally accredited college or university. Students should be employed on a full-time basis or have significant prior work experience in order to relate to the other students and the material covered in the course. Final decision of transferable courses will be made by admission representatives at the Graziadio School of Business and Management, Pepperdine University.

AREA 1: ENGLISH COMPOSITION

(At least 1 course = 3 semester units must be completed with a grade of "C" or better prior to application for admission to the BSM Program)

ENGLISH 1A or 1B

AREA 2: MATHEMATICS

(At least 1 course = 3 semester units must be completed with a grade of "C" or better prior to application for admission to the BSM Program)

MATHEMATICS 3, 5A, 5B, 5C, 8, 9

AREA 3: ARTS AND HUMANITIES

(At least 3 courses = 9 semester units from Area 3)

All courses listed in the Associate Degree General Education requirements under Area C: Humanities for the AA degree **OR** Area C: Art, Literature, Philosophy and Foreign Language for CSU Breadth **OR** Area 3: Arts and Humanities for IGETC **PLUS** the additional courses identified below:

JOURNALISM 4A, 4B, 6, 9, 104A, 109

SPEECH All courses

AREA 4: SOCIAL AND BEHAVIORAL SCIENCE

(At least 4 courses = 12 semester units;

one course for 3 semester units **must** be in US History or American Government)

The following courses meet the U.S. History or American Government requirement:

HISTORY 7A, 7B, 29A, 29B

POLITICAL SCIENCE

The additional nine units (3 courses) for this area may be taken from courses listed above, **OR** all courses listed in the Associate Degree General Education requirements under Area B: Social and Behavioral Sciences for the AA degree **OR** Area D: Social, Political and Economic Institutions and Behavior for CSU Breadth **OR** Area 4: Social and Behavioral Sciences for IGETC **PLUS** the additional course identified below:

BUSINESS 117 (Human Relations)

AREA 5: PHYSICAL AND BIOLOGICAL SCIENCES

(At least 1 course = 3 semester units)

All courses listed in the Associate Degree General Education requirements under Area A: Natural Sciences for the AA degree **OR** Area B1: Physical Science or B2: Life Science for CSU Breadth **OR** Area 5: Physical and Biological Sciences for IGETC.

AREA 6: LIFELONG LEARNING AND PROFESSIONAL DEVELOPMENT

An additional 15 GE units to satisfy the minimum 45 units GE requirement may be drawn from any of the above subject areas <u>PLUS</u> those courses listed under:

Area F: Health Education and Area G: Physical Education (4 units maximum) for the AA degree **OR**Area B4:Mathematics/Quantitative Reasoning **and** Area E: Life-Long Understanding and Self-Development (four-unit limit on activity courses) for CSU Breadth **OR**

Area 2: Mathematical Concepts and Quantitative Reasoning for IGETC

<u>PLUS</u> courses from <u>COMPUTER INFORMATION SYSTEMS</u> and the additional courses identified below:

BUSINESS 11A, 115 **FASHION** 110, 115

AREA 7: ELECTIVES

An additional 23-35 semester units of course work from Areas 1 to 6 above <u>PLUS</u> AA/AS major preparation courses. Other courses not listed above that are applicable to the AA degree may be reviewed for applicability as electives. Students are encouraged to take courses from the following areas to enhance their preparation for the Graziadio School's BSM program: ACCOUNTING; BANKING AND FINANCE; BUSINESS; BUSINESS INFORMATION TECHNOLOGY; COMPUTER INFORMATION SYSTEMS; HOSPITALITY; and MARKETING.

In addition, the following courses have been articulated so as to provide an option for students to WAIVE UP TO 12 UNITS OF BSM COURSE WORK, thus reducing the residential units to be taken at Pepperdine to 48 units. A minimum of four additional elective units are required for each four-unit courses waived.

Grade B or better in ACCTG 1A and either ACCTG 1B or ACCTG 106
to waive ACCT 472 Accounting
Grade B or better in BUS 14A <u>and</u> either STAT 15 or STAT 18
to waive DESC 471 Statistical Methods for Business
Grade B or better in ECON 1A and ECON 1B
to waive ECNM 469 Managerial Economics
Grade B or better in CIS 10 and either CIS 50 or CIS 55
to waive ISTM 476 Information Systems for Business and Management
Grade B or better in BUS 12A and BUS 12B
to waive LEGL 470 Legal Environment of Business

Note that students who waive any of the above courses in the BSM program, and who subsequently enroll in the MBAJ program will be required to complete the equivalent MBA core course.
